4. FIRST-AID MEASURES

- Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. Immediately call a POISON CENTER or doctor/physician.
- Skin contact:** Remove/Take off immediately all contaminated clothing. Gently wash with plenty of soap and water. Immediately call a POISON CENTER or doctor/physician.
- Eye contact:** Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER or doctor/physician.
- Ingestion:** Get medical advice/attention if you feel unwell. Rinse mouth.
- Protection of first-aiders:** A rescuer should wear personal protective equipment, such as rubber gloves and air-tight goggles.

5. FIRE-FIGHTING MEASURES

- Suitable extinguishing media:** Dry chemical, foam, water spray, carbon dioxide.
- Specific hazards:** Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume.
- Specific methods:** Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Remove movable containers if safe to do so.

- Methods and materials for containment and cleaning up:** Sweep dust to collect it into an airtight container, taking care not to disperse it. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.
